WILL VAWTER was born on April 13, 1871. He moved with his family to Greenfield, Indiana, at age six. Young Will loved to draw and would frequently fill the pages of his schoolbooks with sketches. Basically, a self-taught artist, Vawter started doing illustrations for the *Indianapolis Sentinel* in 1891. Soon his work appeared in other newspapers and magazines. Around the same time, another Greenfield native was also making a name for himself as a poet. James Whitcomb Riley, known as the "Hoosier Poet," was a



national bestseller with poems such as "Little Orphant Annie" and "The Raggedy Man." In 1893, Rilev hired Will Vawter as an illustrator. Over the next thirty years, Vawter's work appeared in many of Riley's books. In 1908. Vawter moved from Greenfield to Nashville,

Indiana. There he helped establish what would later be known as the Brown County Art Colony along with other famous Indiana artists.

Despite moving to Brown County, Vawter maintained his Greenfield ties. Will Vawter died in 1941 and was laid to rest in Greenfield's Park Cemetery.

Meet our Juror, **Bruce Neville**



Bruce Allan Neville was born in Rhode Island and studied at the Boston Architectural Center and Wentworth Institute in Boston Massachusetts. Neville moved to Cincinnati, Ohio in 1960 and graduated from the University of Cincinnati in the DAAP program in 1966 receiving a Bachelor of Science in Architecture. Neville is a signature member of the Ohio Watercolor Society, an Associate member of the American Watercolor Society, and a Signature member of the Cincinnati Art Club. Neville has won numerous awards and honors including the RAM Richmond Art Museum Award of Excellence, CAC Viewpoint Award, Boston Mills Award of Best in Show, and two years Best in Watercolor at Carmel International in Carmel, IN. Neville has extensive teaching experience at the college level at the Cincinnati Art Academy and workshops throughout the Midwest.

Neville's style and technique were published in the "The Watercolor Technique of 23 International Artist". My goal is to develop not a style of painting but a way of thinking, interpreting, and being creative.
